

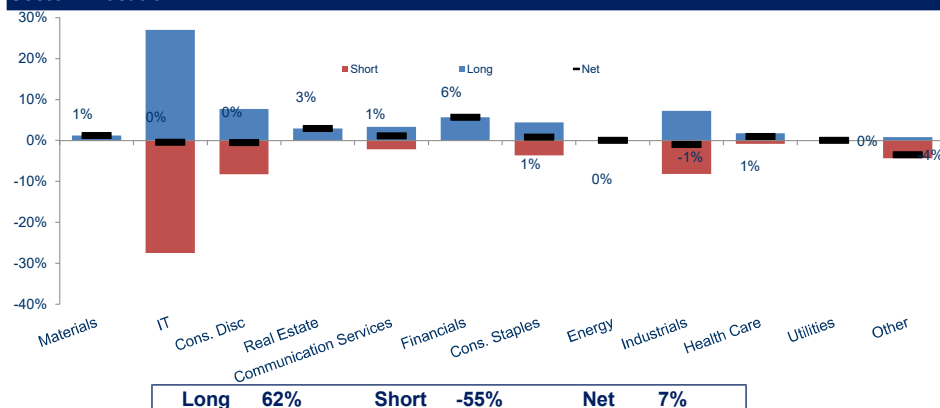

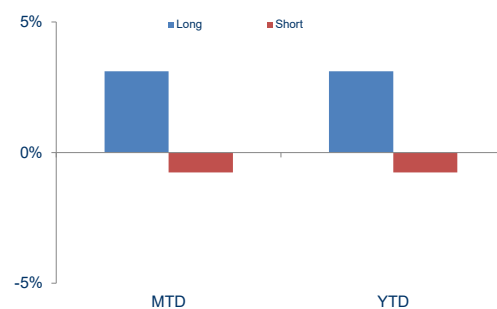

- UCITS Fund launched 22nd May 2017

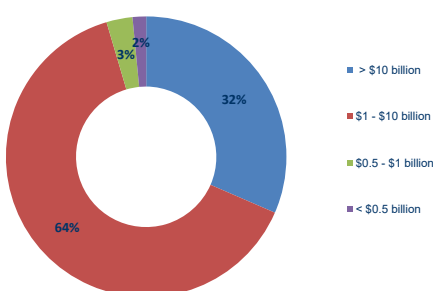
Sector Allocation



Gross Long Short Attribution

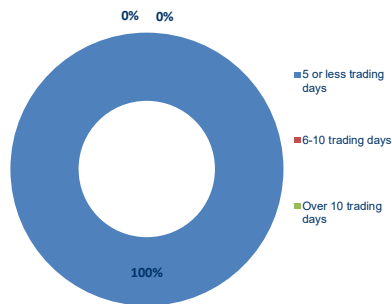


Exposure by Market Cap

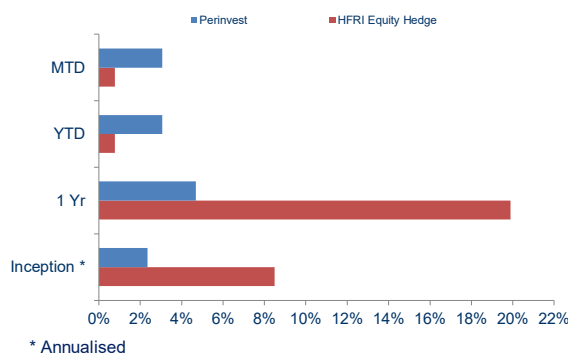


Average Weighted Market Cap: **\$33 billion**
